### **Chaplin Reserve Development**

Since Chaplin Reserve, immediately to the south of the HV McKay Memorial Gardens, was rezoned to a Residential Growth Zone with a Development Plan Overlay (DPO) following the Panel Hearing last year, the developers, Sunshine City Developments Pty Ltd, have pressed on and have lodged a Development Plan (DP) with Brimbank City Council for approval. The Friends have been provided with a copy of this Plan, although it not certain whether there will be an opportunity to lodge any formal comment.

The DP, needless to say, takes full advantage of the Concept Plan which formed part of the Schedule 8 to Clause 43.04 of the DPO, the set of requirements and conditions for the new zone to be complied with when being developed. The building envelopes and height limits have been fully utilised, yielding 265 apartments and 85 townhouses. Along the Gardens boundary, called the interface, there is a height limit of 11m (3 storeys, higher elsewhere), with a set back from the boundary of 5m as required.

One of the provisions of Schedule 8 of particular interest to the Friends is the requirement for an Open Space and Landscape Plan. This is to show a 'clear delineation' between the Gardens and the site to include additional tree planting, a public path to connect to existing paths and front fences to be no higher than 1.2 m The latter two points have been partially addressed, although a potential path link has been ignored and tree planting is limited (see later), but the clear delineation has been somewhat blurred, to the detriment of the Gardens. The existing high chain mesh fence has been removed with nothing to replace it with except intermittent concrete blocks, which show people sitting on them with their feet potentially in the Gardens' garden beds and allows people to bleed into the gardens through garden beds, etc whenever. This is unacceptable - the existing fence should be replaced with a lower chain mesh fence or similar, with openings only where there are specific path connections so the edge of the Gardens is preserved.. Furthermore, the interface for the western third of the boundary effectively becomes the road reserve of the entry road, so does not really read as an interface.

The 'additional tree planting' along the interface in front of the building envelope is located in within private property so could easily be cut down and become non existent. The complicated mathematics set out to prove that the development has a 30% tree canopy cover is erroneous, as it would seem that the calculation of the tree canopy area includes parts of the canopies of 36 trees that overhand the surrounding streets, paths and railway lines, not the site.



Therefore there are not enough trees. (The tree species selected are also questionable as being not sufficiently robust for the site conditions and with the exception of one, unfortunately have no link to the species in the Gardens.)

The entry road, which was point of contention at the panel hearing as it had the potential to excise a small corner from the Gardens at the south west corner, seems to have been resolved so that there is now a signalised intersection to serve the development and no restrictions to the entry to the church car park. However the DP states there are conditions imposed by VicRoads, which are not stated. The road entry is comparatively narrow and uninviting, with the distant view only to the side of a townhouse, the proposed entry treatments being very low key. A suggestion to relieve potential congestion at peak times and improve visual appeal, would be to widen the road for outgoing traffic to two lanes, one to turn left and the other to turn right and stagger the alignment of the townhouses and/or turn the corner townhouses to face the street.

Generally the DP relies heavily on the HV McKay Memorial Gardens; there is no provision for bicycle paths, apart from the local road - the site utilises the South Walk paths in the Gardens to provide the site's connections to the pedestrian bridge in particular, a ridiculous proposal. Public open space is minimal with a pathetic hard paved children's playground squashed into the northeast corner, barely visible to most of the dwellings on site. Others may have other comments and/or objections, and are urged to view the DP should it it be made available for public consultation. (As an aside, the important aviation fuel line is shown on the wrong location on two plans.)

## **Hellebores – Winter Roses**

Winter rose is one of the many names given to plants in the Helleborus group.

They have attractive leathery leaves, often with spiny borders, and pretty, open, cup-shaped flowers that look a bit like single roses (hence the name) in shades of pink, maroon and cream. The Corsican hellebore produces pendent, bowlshaped, beautiful green flowers.

Hellebores flower from late-winter to early spring .They will tolerate full sun to almost full shade. They're hardy and rarely troubled by pests and diseases, they will self-seed readily all over the garden. They grow in most conditions, but thrive in well-drained, humus-rich soil, out of direct sunlight. They can handle dry periods, which makes them ideal for use as ground covers under established trees.

#### The Management Plan

The Friends have continued to assist Brimbank Council in developing the long-overdue Management Plan for the Gardens, re-writing sections and attempting to inform the plan with our knowledge and the expertise we have on the Committee.

A Management Group has been set up for the Gardens and has met twice. There does not appear to be any money set aside for the 'heritage' activities outlined in the Management Plan, and the Friends remain concerned that until this is addressed the Plan cannot be effectively implemented.

The Friends have made a number of submissions to Council, including submissions on the latest budget and on the Brimbank Tourism Strategy. Individual members have also made submissions on the Budget and the Brimbank Heritage Strategy. We have given content for the Brimbank Environmental Booklet.
